Traveling I - 91 North – Take Exit 15. At the end of the exit ramp, turn left onto Route 68 West. Proceed to 7th traffic light (intersection of Route 68 and North Main Street Extension). Take a left turn onto North Main Street Extension. At the first traffic light, take a left into driveway of 860/866. At the top of the hill proceed to the building straight ahead.

Traveling I - 91 South – Take Exit 15. At the end of the exit ramp, turn right onto Route 68 West. Proceed to 6th traffic light (intersection of Route 68 and North Main Street Extension). Take a left turn onto North Main Street Extension. At the first traffic light, take a left into driveway of 860/866. At the top of the hill proceed to the building straight ahead.

Wilbur Cross Parkway (Route 15 Going North) Exit 66

At the end of the exit ramp, turn left onto Route 5 South. Proceed approximately ¼ mile to the 3rd traffic light, following signs to Route 68. At top of hill, turn left on Route 68 East. At first traffic light, turn right onto North Main Street Extension. At the first traffic light, take a left at the driveway of 860/866. At the top of the hill proceed to the building straight ahead.

Wilbur Cross Parkway (Route 15 Going South) Exit 66

At the end of the exit ramp, turn left onto Route 5 South. Proceed approximately ¼ mile to the 5th traffic light, following sign to Route 68. At top of hill turn left on Route 68 East. At first traffic light, turn right onto North Main Street Extension. At the traffic light, take a left at the driveway of 860/866. At the top of the hill proceed to the building straight ahead.

From Interstate 84: Exit 27

Proceed on Route 691 East to the Wilbur Cross Parkway Southbound and follow directions above.

Connecticut law requires employers with 50 or more employees to provide sexual harassment training of supervisors within 6 months of assuming a supervisory role. In addition, it is suggested by the Connecticut Commission on Human Rights and Opportunities that sexual harassment training be updated every 3 years. This program will meet the requirements of that law and provide you with a complete understanding of the various areas of sexual harassment; including how to investigate a sexual harassment claim and how an employer may be able to avoid liability by acting promptly to address any sexual harassment.

PROGRAM SPEAKER

Attorney Andrew Cohen, of counsel with the law firm of Letizia, Ambrose & Falls in New Haven will conduct the training. Mr. Cohen graduated magna cum laude from the Georgetown University Law Center in 1986, after serving as Managing Editor of the Georgetown Law Journal. He then clerked for U.S. District Judge Harold H. Greene and practiced with the Washington, D.C. office of Kaye, Scholer, Fierman, Hays & Handler, where he worked on complex civil litigation.

Since his arrival in Connecticut in 1990, Mr. Cohen has practiced extensively in the areas of wrongful discharge, wage and hour, workers' compensation and the related issues between employees and employers. He has represented employers in court proceedings, administrative hearings and other forums, has been primarily responsible for appeals of important employment and workers' compensation issues, and has been a frequent speaker at seminars on employment law. Mr. Cohen also serves as special master for employment cases pending in the U.S. District Court for the District of Connecticut.

Mr. Cohen is a frequent speaker at seminars on the Americans with Disabilities Act, sexual harassment and related topics.
